It was noted that each County has two voting reps, more members per County can attend however only two members can vote.

Katie explained that tonight's meeting was to gather feedback from the Virtual Royal Welsh and to discuss future Wales YFC Competitions such as dates, locations and rules for those competitions.

C/85/2021 ACTION POINTS AND MATTERS ARISING FROM THE MINUTES

There were no matters arising from the previous minutes.

C/86/2021 CORRESPONDENCE

None were received.

C/87/2021 TO DISCUSS FUTURE COMPETITIONS**a) Virtual Royal Welsh 2021 Feedback**

Katie Court opened the floor to the Committee Members to ask if they had any feedback, although it was noted that the Competition was pretty raw and not many members would have discussed in their Counties as of yet.

Mared Jones wished to note with her RWAS cap on that she had received good feedback regarding the YFC programme during the week and wished to thank everyone for all their work towards the week.

Some of Brecknock YFC members who took part in the Stockjudging Competitions preferred to do the stockjudging competition like it was in 2020.

It was agreed to add this topic in the next Committee Meeting agenda, as more Counties would have met to discuss further feedback.

b) Agri Day

The Agri Day will be held at the Showground, Llanelwedd on 15th August 2021. With the Shearing in the Shearing Shed, and Stockman competition in the stock sheds. The TOW, Fencing and Farm Safety will be located down by the main entrance next to the Builth Roundabout.

c) Sports Day

The Sports Day will be held on 12th September 2021 at Aberystwyth with Kwik Cricket, Ladies Netball, and Male Football.

d) 2021-22 Competitions

Eisteddfod – Pafiliwn Bont, Pontrhydfendigaid has been booked for 20th November 2021. £2250 including setting up.

Winter Fair – The Winter Fair competitions will be held on the 29th and 30th November at the Showground, Llanelwedd.

Entertainment – The Entertainment Final will be held on the 5th and 6th March 2022.

The Competitions Committee had received a quote of £8000 including VAT for one day or £5000 per day for 2 days for the ICC, in Newport but had agreed to look at further locations to compare prices.

Dolman Theatre, Newport had been approached but were unavailable for that date.

The Princess Royal, Port Talbot was available for that date, and had come back with a quote, although Wales YFC have asked for a further quote with everything included rather than just a price per hr for the theatre hire and technicians.

The Ffwrnes, Llanelli has also been approached but no answer as of yet.

It was agreed that Wales YFC would try and receive further quotes and the Competitions Committee will make a final decision in the September meeting.

The Public Speaking (26th + 27th March) and Royal Welsh (18th-21st July) was noted as being located in the Showground, Builth Wells.

The 2022 Field Day would be held on 23rd April 2022 and further discussion will need to be held with Clwyd YFC.

The Sports Day would be 19th June 2022 at Aberystwyth.

C/88/2021 2021-22 COMPETITION RULES

It was agreed in the previous Competition Committee Meeting that the Committee would be having a look at the 21-22 rules to circulate out to Counties.

Eisteddfod – Brecknock YFC Eisteddfod Committee have met and have discussed some competitions. The updated rules were shown to the Committee. Brecknock YFC had asked if some of the competitions could be changed, in line with the age range of the YFC: e.g Under 16, 21 and 28. This was agreed.

It was also agreed that the closing date for the Eisteddfod would be the Tuesday 2nd November.

Winter Fair – The winter fair rules were shown and agreed by the Committee. It was also agreed that Winter Fair promotion video would stay rather than a Winter Fair promotion sign. It was also agreed that rules for the Baby Calf and the Lamb would need to be circulated soon as.

The closing date for the Winter Fair entries were agreed for Monday 15th November.

Entertainment – The Entertainment rules were shown on the screen. NFYFC had not circulated the 21-22 rules as of yet, so the English Pantomime and Member of the year Competitions could not be passed 100% until received.

It was agreed an intention of entry and £250 deposit would need to be in by 18th October 2021.

Public Speaking – The Public Speaking Competitions and rules were shown to the Committee. It was agreed to use the competitions for Public Speaking.

It was also agreed that entries will need to be in by 28th February for the topics to be set out on 4th March.

Field Day – The competitions were shown to the committee and it was agreed to use the competitions shown.

Sports day – It was noted that NFYFC have chosen Ultimate Frisbee (10-16), Mixed Rush Hockey (17 -28), Mixed Dodgeball (17-28) as their sports competition. After a discussion it was agreed that members were to come back in the September meeting to agree on Wales YFC sports.

Royal Welsh – It was noted that the Competitions Committee had agreed that the Royal Welsh Rules would not be changed, from the rules that were made for the 2020 Royal Welsh. A proposal was given to add a Chairman Generation Game, and this was agreed.

Mared Jones also noted that Dwr Cymru had been in contact to say that they would be interested in sponsoring a competition. After a discussion, it was agreed that the Royal Welsh Federation Display competition would be changed to "Your Welsh Water" sponsored by Dwr Cymru.

C/90/2021 ANY OTHER BUSINESS

- a) Ynys Môn asked when they would be hosting the Eisteddfod. It was noted that Brecknock YFC would be hosting the 2021 Eisteddfod, Pembrokeshire 2022 and Ynys Mon 2023.
- b) Pembrokeshire YFC wished to ask why was it decided to centralise the Eisteddfod locations to North, Mid and South and to note their concern that stewards will not be willing to travel to a location such as Bridgend rather than if it was in their own County or a County next door.

It was noted that centralising location was due to try and reduce costs and to know where we would be holding the Eisteddfod every three years. It was noted that host Counties would still be agreeing on competitions, and stewarding the day as a normal host County do. It was also noted that centralising location would benefit the TV crew, that they know the location and don't need as much leading up to the day as they will be familiar with the venue.

After a discussion it was recommended that for the Eisteddfod Wales YFC could ask the Counties from each location to help with stewarding. E.g South Eisteddfod – ask Counties from the South.

As there was no other matter arising, the members were thanked for their contributions and the meeting was closed at 20.45pm.
